



NTN LIMITED WARRANTY

ROTTEFELLA warrants that this product, when it is purchased from an authorized ROTTEFELLA dealer by a retail customer, will be free from defects in materials and workmanship for a period of two (2) years from the date of purchase by the original retail customer. This warranty is solely for the benefit of the original retail purchaser and may not be assigned.

For retail customer Limited Warranty claims, proof of purchase from an authorized ROTTEFELLA dealer is required. If the date of purchase cannot be established, ROTTEFELLA will make a determination based upon the last production year of the particular model.

If you have any questions about ROTTEFELLA Limited Warranty or procedures for making claims thereunder, please contact ROTTEFELLA at www.rottefella.no. The ROTTEFELLA Warranty Center will determine if a product is covered under this Limited Warranty. If covered, ROTTEFELLA will, at ROTTEFELLA's sole option, repair or replace the product in question.

All returns must be made through ROTTEFELLA authorized dealers or distributors. ROTTEFELLA does not accept returns directly from consumers retailers must call for a Return Authorization Number before returning any product under this Limited Warranty. All authorized returns must be sent to ROTTEFELLA Warranty Center at a distribution office, freight prepaid. ROTTEFELLA will pay the freight for the return shipment.

Any repair or replacement of any product under this Limited Warranty is not available for ordinary wear and tear, including scratches and paint chips or any damage caused by misuse, abuse, unauthorized modification or repairs, accident, heat, improper maintenance or care, incorrect setup, use on non-snow objects and any blow or impact with any hard object. Additionally, any repair or replacement of any product under this Limited Warranty is not available for any product put to any non-recreational use.

THE FOREGOING LIMITED WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES OF QUALITY AND PERFORMANCE, WRITTEN, ORAL OR IMPLIED AND ALL OTHER WARRANTIES, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE HEREBY DISCLAIMED. IN NO EVENT SHALL ROTTEFELLA OR ITS DISTRIBUTORS BE LIABLE FOR SPECIAL, INDIRECT, INCIDENTAL, CONSEQUENTIAL, STATUTORY OR EXEMPLARY DAMAGES, WHETHER IN CONTRACT, TORT, NEGLIGENCE, STRICT LIABILITY OR OTHERWISE including, without limitation, loss to property other than this product, loss of use of said product or other property or other economic losses. Either ROTTEFELLA or its distributors shall not be liable for contribution or indemnification, whatever the cause.
